### Old Business New Business

#### **Business From the Floor**

<u>EMS meeting</u>- Aileen Parrish and Brian Sachs attended a meeting held in London Grove Twp. who hosted the meeting with Townships for Medic94. There was overwhelming support for the 3 tier funding system for Medic 94 which calls for a funding system based on a third for population, third for number of Medic 94 calls and a third based on millage. The 3 tier system is much more fair and is the same system used for the fire companies. This year the Township budgeted based on a 2 tiered system and will need to factor in the 3 tier system for 2021 budget.

<u>Brandywine Conservancy</u> will be the Township consultants for review/updating of the Subdivision and Land Development Ordinance (SALDO). Stephanie Town announced that there will be a meeting with Susan Elks from Chester County Planning, members of the Township Planning Commission and Township Treasurer Nette Stejskal to discuss a grant which will pay for a good portion of the SALDO updating and review.

Scout member Lincoln Midgette, as part of a citizenship badge, presented a list of concerns to the Board of Supervisors. The first concern is the north end of Sharpless Rd. Joe Ferguson explained that Sharpless Rd is on the Township 10 year plan. A second concern is no bus stop sign at the intersection of London Tract Rd/Sharpless/South Bank Rd near the meeting house. Roadmaster Joe Ferguson will place a bus stop sign. Brian Sachs suggests informing the State police of the repeat offenders not stopping at the intersection.
