Board of Supervisors Meeting

Glenn Frederick, Chairman of the Board of Supervisors opened the meeting at 7:04 pm. New Business

Aileen Parrish sadly noted that longtime Land Trust member, important member of the London Britain Township community and Veterinarian Debby Roberts died on Wednesday June 20, 2018. The Township and community will miss her dearly.

Timbering and Woodlands Ordinance- Planning Commission member Stephanie Town asked whether the Board of Supervisors were interested in the Planning Commission researching a Timbering or Woodlands Ordinance further.
