## **Board of Supervisors Meeting**

Glenn Frederick, Chairman of the Board of Supervisors opened the meeting at 7:06 pm. Aileen Parrish noted that after a Township request to do so, Verizon is looking again at possibly bringing in service to the Township.

#### **Old Business**

<u>Longs Asphalt Contract-</u> Nette Stejskal noted that they were awarded the contract for the Township. The contract deadline was 8/1. Due to weather the deadline cannot be made. Longs Asphalt says they can get to the Township in the first half of September. There is an option in the contract where the Township can charge penalties for not honoring the contract date. <u>Volunteer Firefighter Tax Credit</u>- Glenn Frederick noted that the Township is in receipt of a Volunteer Firefighter Tax Credit Ordinance which would give up to a 20% tax credit to active firefighter volunteers. The Township is researching further.
