Aileen Parrish, Chairman of the Board of Supervisors opened the Board of Supervisors meeting at 7:07 PM. In attendance were Supervisors Glenn Frederick and Brian Sachs, Secretary Carolyn Matalon, Treasurer Nette Stejskal, Planning Commission member Don Morgan, Park and Recreation member Bill Maslanka and residents.

<u>Executive Session</u>- Aileen Parrish noted that an Executive session was held tonight to discuss personnel and an Executive Session will be held tomorrow evening 2/25 to discuss legal for another matter.

New Business

<u>Resolution #20-9</u> – Aileen Parrish read the resolution to appoint Allison Thomas to the Avon Grove Library Board. Glenn Frederick made a motion to adopt Resolution #20-9 as written. Brian Sachs seconded, and the motion carried unanimously.

Resolution #20-10 — Aileen Parrish made a motion to approve the London Britain Sewage rates for 2020 at \$13,605.00 with additional costs to be recovered for the system failure and replacement of \$15,276.81 and declare these costs be assessed as a monthly fee of \$2,406.80 as written. Glenn Frederick seconded, and the motion carried unanimously.

Old Business

Nette Stejskal stated the road information will be ready for discussion at the 3/9/20 Board of Supervisors meeting. Nette Stejskal asks for a special meeting to open road bids at the end of March or beginning of April.

<u>Ridgewood Rd and Good Hope Rd</u>- Glenn Frederick noted that the road crew, this year, will tar and chip the pothole which is located at the end of Ridgewood Rd and always fills with water and ice. This will be discussed as part of the roads discussion on 3/9/20.

<u>Windsor Escrow discussion</u>- Bruce Yost noted that discussion was tabled in 2019. Nette Stejskal stated that the best result for the Windsor residents will be discussed after the road projects are completed.
